



Vendor Privacy Notice

1. Overview

This privacy notice explains our collection, use, and sharing of personal information relating to Adobe’s vendors and business partners. This privacy notice applies to Adobe Inc. and to our controlled affiliates and subsidiaries (“Adobe”) and supplements Adobe’s Privacy Policy which can be viewed at www.adobe.com/privacy (“Adobe’s Privacy Policy”).

2. What personal information is collected?

The personal information collected may vary depending on your location, the systems you use, and the choices you make.

Information you provide directly. We collect personal information you provide to us. For example:

- **Contact information**, such as name, email address, telephone number, and employer;
- **Payment information**, such as financial account information and other payment details;
- **Onsite visit information**, such as personal vehicle information, visitor badge data, CCTV footage, Adobe office building location, or names of individuals you interacted with while onsite;
- **Content and files**, such as photos, documents, or other files you upload to our online systems; and if you send us email messages or other communications, we will collect and retain those communications.

Information we collect automatically. When you interact with our online systems, we collect some information automatically. For example:

- **Identifiers and device information**, such as Internet Protocol (IP) address and information about your device, including device identifiers (such as MAC address); device type; and your device’s operating system, browser, and other software including type, version, language, settings, and configuration.
- **Usage data**, such as the URL of the website from which you came to our sites, pages you viewed, how long you spent on a page, access times, and other details about your use of and actions on our website.

Information we create or generate. We may infer new information from other data we collect, including using automated means to generate information about where you are logging in from (“inferences”).

Information we obtain from third-party sources. We may also obtain information from third parties. These third-party sources include, for example:

- **Data brokers.** Data brokers and aggregators from which we obtain data to supplement the data we collect.
- **Service providers.** Third parties that collect or provide data in connection with work they do on our behalf, for example companies that collect identifiers and device information for our audit logging purposes.
- **Publicly available sources.** Public sources of information such as open government databases.

3. How does Adobe use this information?

Adobe uses this information to administer and carry out the business relationship and for our operational, business, legal, safety, and security purposes, and as described in this privacy notice, including without limitation:

- **Communicating and collaborating with you.** Such as to send you information, including confirmations, payments, technical notices, updates, security alerts, and support and administrative messages;
- **Business operations.** Such as to operate our business, such as billing, accounting, improving our internal operations, securing our systems, and detecting fraudulent or illegal activity;
- **Legal and regulatory compliance.** Such as record-keeping activities, meeting our legal obligations, and notifications required by applicable law.

We may combine data we collect from different sources to achieve these purposes.

4. Does Adobe share my personal information?

Adobe may share personal information with other Adobe group companies, fraud prevention, safety, and security providers, and service providers for purposes described in this notice and the Adobe Privacy Policy.
